





Read instruction manual before use. Operation of this device without understanding the manual and receiving proper training is a misuse of this equipment. A person who has not read and understood all operating and safety instructions is not qualified to operate the Pressure Relief Valve.


This instruction manual is intended to familiarize firefighters and maintenance personnel with the operation, servicing and safety procedures associated with the Pressure Relief Valve.

This manual should be kept available to all operating and maintenance personnel.









PERSONAL RESPONSIBILITY CODE

The member companies of FEMSA that provide emergency response equipment and services want responders to know and understand the following:

- Firefighting and Emergency Response are inherently dangerous activities requiring proper training in their hazards and the use of extreme caution at all times.

1.0 MEANING OF SAFETY SIGNAL WORDS

A safety related message is identified by a safety alert symbol and a signal word to indicate the level of risk involved with a particular hazard. Per ANSI standard Z535.6-2011, the definitions of the four signal words are as follows:



DANGER indicates a hazardous situation which, if not avoided, will result in death or serious injury.



WARNING indicates a hazardous situation which, if not avoided, could result in death or serious injury.

ACAUTION CAUTION indicates a potentially hazardous situation which, if not avoided, may result in minor or moderate injury.

NOTICE

NOTICE is used to address practices not related to personal injury.

2.0 GENERAL INFORMATION



Do not connect this valve to continuously wetted brass or stainless steel piping. Connecting dissimilar metals can cause galvanic corrosion to the wetted areas. Apply an anti-corrosive lubricant to the mating surfaces. Inspect the valve annually.

The Pressure Relief Valve may be set to any pressure between 90 and 300 psi. Its function is to protect the pump and the supply hose from excess pressure. The relief valve may be mounted with its opening facing the front, back, right or left. A section of tubing or pipe may be mounted on the round spout to route the water in any direction. To install the Pressure Relief Valve;

1) Install the O-ring in the groove on the Pressure Relief Valve.

2) Install four 7/16" bolts through the Pressure Relief Valve flange. Use a drop of thread locking compound on the threads of the bolts to prevent them from coming loose.

3.0 RELIEF VALVE PRESSURE SETTING

To set the relief valve pressure turn the adjusting screw on the relief valve housing until the surface of the screw is even with the desired pressure. Do not cap or plug discharge opening. To turn off the Pressure Relief Valve, align the adjusting screw with the Off position. Placing the Pressure Relief Valve in the Off position, prevents the valve from venting water. Do not use the Off position for normal operations. System damage may occur if the Pressure Relief Valve is in the Off position and the system exceeds its operating limits. The pressure relief valve meets the requirements of NFPA 1901.




Image: 90 PSI200 PSIOFF

Use either a 1/4" Allen or 9/16" wrench when setting the height of the adjusting screw to the desired relief pressure.




Do not leave the pressure relief valve in the OFF position. The pressure relief valve is disabled in the OFF position and offers no protection against over pressurization. The OFF position may be used for controlled pump testing but should not be used for service conditions. Exercise great care to avoid water hammer or other pressure spikes when the pressure relief valve is in the OFF position.




The Pressure Relief Valve will open to relieve excess pressure but it may not have enough flow capacity to protect against large pressure spikes such as those caused by water hammer. Excess pressure can cause equipment failure and directly or indirectly lead to injury or death. Always operate valves slowly to avoid the risk of water hammer.

6.0 MAINTENANCE AND INSPECTION

The Pressure Relief Valve requires no routine maintenance but should be tested regularly. Since the Pressure Relief Valve may not need to open in normal use it is important that it be inspected at least quarterly for proper function per NFPA 1962 section 6.3.2. In particular assure that:

- There is no damage such as cracks or dents
- There is no corrosion
- Setting indications are readable
- The waterway is clear of obstructions
- The valve opens at the set pressure (see below for test instructions)

If any problems are found, the Pressure Relief Valve should be removed from service until the problem is corrected. Any repaired Pressure Relief Valve must be tested before being placed in service.

The Pressure Relief Valve may be damaged if frozen while containing significant amounts of water. Such damage may to difficult to detect visually and can lead to possible injury or death. Any time the Pressure Relief Valve is subject to possible damage due to freezing, it must be hydrostatically tested by qualified personnel before being considered safe for use.

It is important that your Pressure Relief Valve (PRV) is functioning properly at all times while in service. A properly functioning PRV prevents dangerous situations and reduces possible injury. In order to ensure the PRV is functioning properly, it should be tested regularly. NFPA 1962 Section 6.3.2 set forth the minimum standards and procedures for use of these valves. It is strongly recommended that you read and follow these procedures. In addition, TFT recommends testing the PRV semi-annually to the following test procedures.

- 1. Set up the line with a pressure gage upstream from the appliance and pressure relief valve.
- 2. Make sure the PRV is set to your operating pressure, and close all appliance outlets.
- 3. Fill the appliance with water using pressure less than where the PRV is set, being sure to bleed all air out of the system.
- 4. Carefully increase the pressure on the appliance to the set pressure. Check to see if the valve has opened to allow water to escape. If the valve has not opened and there is no water, increase the pressure by 5psi, If the valve has not opened, the valve has failed and should be taken out of service immediately

Any valves taken out of service due to failure should be returned to the factory for repair or replacement. If you have any questions regarding the testing or maintenance of your pressure relief valve, please call Task Force Tips at 800-348-2686.

7.0 WARRANTY

Task Force Tips, Inc., 3701 Innovation Way, Valparaiso, IN 46383-9327 USA ("TFT") warrants to the original purchaser of its Pressure Relief Valve ("equipment"), and to anyone to whom it is transferred, that the equipment shall be free from defects in material and workmanship during the five (5) year period from the date of purchase.

TFT's obligation under this warranty is specifically limited to replacing or repairing the equipment (or its parts) which are shown by TFT's examination to be in a defective condition attributable to TFT. To qualify for this limited warranty, the claimant must return the equipment to TFT, at 3701 Innovation Way, Valparaiso, IN 46383-9327 USA, within a reasonable time after discovery of the defect. TFT will examine the equipment. If TFT determines that there is a defect attributable to it, TFT will correct the problem within a reasonable time. If the equipment is covered by this limited warranty, TFT will assume the expenses of repair.

If any defect attributable to TFT under this limited warranty cannot be reasonably cured by repair or replacement, TFT may elect to refund the purchase price of the equipment, less reasonable depreciation, in complete discharge of its obligations under this limited warranty. If TFT makes this election, claimant shall return the equipment to TFT free and clear of any liens and encumbrances.

This is a limited warranty. The original purchaser of the equipment, any person to whom it is transferred, and any person who is an intended or unintended beneficiary of the equipment, shall not be entitled to recover from TFT any consequential or incidental damages for injury to person and/or property resulting from any defective equipment manufactured or assembled by TFT. It is agreed and understood that the price stated for the equipment is in part consideration for limiting TFT's liability. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above may not apply to you.

TFT shall have no obligation under this limited warranty if the equipment is, or has been, misused or neglected (including failure to provide reasonable maintenance) or if there have been accidents to the equipment or if it has been repaired or altered by someone else.

THIS IS A LIMITED EXPRESS WARRANTY ONLY. TFT EXPRESSLY DISCLAIMS WITH RESPECT TO THE EQUIPMENT ALL IMPLIED WARRANTIES OF MERCHANTABILITY AND ALL IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE. THERE IS NO WARRANTY OF ANY NATURE MADE BY TFT BEYOND THAT STATED IN THIS DOCUMENT.
